### **Dealer Reimbursement:**

Supplier Purchase Program (SPP) incentives are reimbursed by Audi Canada. All claims must be submitted within 60 days from the date of sale. To register the sale under this program and to receive reimbursement, go to the corporate sales website (www.audicorporatesales.com) and select the 'Electronic Funds Transfer' link under the Supplier Purchase Program section.

### **Audits:**

All claims submitted by a dealer or its staff must be proven upon request. Audi Canada retains the right to audit dealer records and to disqualify a transaction if it is not eligible under the terms of this program.
